Operational Issues	<ul style="list-style-type: none"> <li>Supervise the playground area, playing fields, cloakrooms and classrooms etc during the lunchtime break.</li> <li>Assist with the removal of food and equipment once pupils have eaten their lunch.</li> <li>Deal with minor first aid incidents; follow appropriate procedures for recording and reporting.</li> <li>Assist in the implementation of appropriate behaviour management strategies as required</li> <li>Observe a child or young person's behaviour, understand its context, and notice any unexpected changes and report any inappropriate behaviour to the correct member of staff.</li> <li>Resolve minor disputes between pupils</li> <li>Assist in the supervision of other activities during the midday break, including setting out and storing equipment</li> </ul>
